# Report from the AAI Coach Manager July 2017

#### **Endurance session 2:**

We held the second endurance course at Mt. Smart stadium on the 15 June 2017, again led by Mathew Mildenhall. We had eight coaches present discussing items based on feedback from the first course. I will hold a meeting with Mathew on the future direction of these courses in late July or early August. The goal is to increase the number of participants over time to encourage discussion between coaches on endurance training issues.

# John Walker Find your field of Dreams:

In consultation with Peter Wyatt, presented a new proposal to Rick Pickard CEO of the JW Field of Dreams programme. We have presented a budget of \$18,576, including the session plans. Rick has identified four schools, mainly the same one that AAI coaches delivered to last year.
