#### Athletics Auckland Development Report February 2013

#### College Sport

All the College Sport Athletics and Cross Country and Road Zone Championships and Auckland Championships dates have been set and Athletics Auckland we be coordinating all the technical officials and equipment. There will be one zone championship at Papakura, Waitakere and North Harbour, two zone championships at Mt Smart and the Auckland Championship Meet at Mt Smart on Tuesday 26<sup>th</sup> March. They have asked for a total of 10 officials for all there meets. With such a heavy reliance on us for these events this is the time to start discussions on how we can work more closely for Athletics and Cross Country.

Schools

With Mt Smart out of action, most secondary schools that usually come to Mt Smart have moved to either Pakuranga or Papakura. The first school meet at Mt Smart will be on Friday 1<sup>st</sup> March.

The first school meet (St Peters College) was held on Friday at Pakuranga with the majority of schools starting next Monday. We are going to start doing some marketing of the nationals to the schools and the Regional Sports Trust. This will include posters advertising the championships with a picture of Valerie Adams.

### New Zealand Track and Field Championships

All three grant applications for the Championships were successful. Total money received was \$5600. Through some contacts from the LOC and Carl Jackson there are three confirmed sponsors and these being STI NZ Ltd (Company Construction the new track), Green Valley Pure Milk and Auckland Co-Op Taxi. Peter Wyatt, Peter Booker and I met with Shannan Faulkner and Phil Briars on Tuesday to discuss the stadium details for the Championships. Discussions were around room's required, general tidy up of surrounding areas, sound systems, security, catering and layout of the stadium.

All the sponsors for the Championships will be delivering their signage to the office by the  $10^{th}$  March at the latest. Also, there is a dinner being held at the Ibis Hotel. We have sold 38 tickets out of 60 tickets.

Part of the marketing for the schools also includes getting some stories about athletes and their performances and using them in the local suburban newspapers. By doing this it not only advertisers the championships but may also generate interest around the event. There is also the possibility that some of last year's Olympians will visit some of the schools as well.

The Mayor's Letter for the programme has been received and has been passed on to Dave Norris who is preparing the programme.

#### New Zealand Combined Events Championships

I am working with Peter Booker and Will Stewart on the final organisation for the event. This Championship event will be held at Waitakere on Saturday and Sunday from 11am-4pm. We have received 31 entries. This is exactly the same number of athletes that competed when the championship was last held in Auckland in 2009. The programme has been designed and will be printed from the office with each athlete and official receiving one. All welcome to attend.

#### Coaching

Dave Norris has put together a coaching programme for the rest of this season. There was 5k from AAI, ANZ and Greater Auckland Coaching Unit (GACU). The programme is now available to clubs to take up. Dave and I are working on the coaching clinics and they should be finalised by the end of next week. The coaching document is attached to this report.

### Sport Waitakere

I have a meeting on Thursday with Michael Mau the Sport Development Manager at Sport Waitakere and some members of the local community in Kelston who want to restart the Kelston Athletics Club. They are looking at a start date of October 2013.
