## Risk:

#### Covid 19:

• If any new community cases arise and lock down levels are re-introduced, Board to act accordingly to regulations.

## **Child Protection Policy:**

• Proposed changes to Competition Regulations - Community Volunteer Membership 50 day consultation period closed for feedback on 5 January 2021. The 11 NZ centres agreed to a requirement for all centre team managers and other official team members to hold Community Volunteer Membership, Community Coach Membership or Accredited Coach Membership. The changes proposed to the Competition Regulations will make this a requirement for centres, rather than voluntary. The changes are to add new Competition Regulations 4.9 and 10.3 and amend Regulations 10.1 and C3.8.

### Social Media:

- DS asked the Board once again to discuss derogatory comments posted to the AAI Facebook page by members of the Athletic community. After discussion Board confirmed an Anti Harassment and Abuse Policy. This is especially applicable to our online presence, and follows the request at last year's AGM for a policy and action.
- Any swearing, harassment, assault or abuse on our sites will not be tolerated, and will
  result in the post being removed.
- The person posting is to be banned until the next available Board meeting. The Board will discuss the case and will then decide what should be done next, whether to continue the ban, any other action, and on when the ban ends.

### Mt Smart:

- As a tenant at Mt Smart #2 Arena, Auckland Unlimited require that Athletics Auckland comply with the Health and Safety at Work Act 2015 and associated regulations. As a tenant AAI are eligible to submit a long term event health and safety plan. The plan is valid for 12 months from Monday 1 April 2021 and must be reviewed and resubmitted to Auckland Unlimited on an annual basis.
- Mt Smart will have their first event of 2021 on 23/1/21 with Drifting to be held on the Big Top area. This will co-incide with a McKinnon Shield event on the #2 Arena starting 2pm with the last event at 6.15pm. The main Drifting event starts at 6pm but there will be practice rounds from 1pm.
