### Risk:

- **AAI Business Plans**. Reference to the Business Plan has been made in the 2022 AAI Annual Report.
  - 1. T&F: Having ongoing discussions around pros and cons of bringing back a EOY Prize Giving.
  - 2. XCR: Planning for new Road Race on Calendar. Securing a Road venue is the biggest challenge. Looking to hold first Prize Giving post covid lockdowns.
  - 3. Junior: Covid Recovery Plan becomes the immediate focus.
- Covid Recovery Project:
  - 1. AAI and ANZ Representatives have met to put into motion an AAI Covid recovery plan to help all clubs but particularly Junior clubs with member recruitment following low registrations in the 2021/22 season during covid lockdowns. Fiona Maisey from ANZ has also spoken at the July Junior Delegates meeting outlining initiatives for AAI to now pick up on and take the lead.
  - 2. Board discussed how this will be rolled out and what part the Board/current staff/sections will pick up on and lead and the need to employ a Short Term Covid Recovery Specialist.
  - 3. LK summarised the Junior Delegates meeting 2/7/22 and thanked Fiona Maisey (ANZ) and Tania Boyer for their contributions. ANZ would like to organise a club development workshop on either 20<sup>th</sup> or 27<sup>th</sup> August covering member acquisition/retention, engaging more parent helpers/volunteers, with an opportunity for clubs to share ideas and experiences with each other. Junior Delegates voted to bring Term Deposit funds maturing in early August back into Junior General account as part of assisting clubs.
  - 4. Board discussed the need to employ someone with expertise to lead the Covid Recovery project up to the start of the Summer Season. BH advised that with a short lead in time that Coaching Manager be utilised initially to contact clubs to gather information that could be beneficial in the workshop. This could then be taken over by the Covid Recovery Specialist. Board will move forward with interviews for this short-term position.
  - 5. Board listed the components of the Recovery Plan as
    - (i) Club Development Workshop
    - (ii) Member Recruitment Campaign

(iii) Communication support

- (iv)Improve coaching hubs around Auckland
- (v) Liaison with other organisations.
- (vi) Renewed Interclub events and kick off events come under Calendar and will be part of the whole process.

The Board will talk at the AGM on – Day Workshop – Event Planning (encouraging more kids to re-engage with different incentives e.g: adding points for participating.

• **SDO Role:** MM and BH have interviewed for the SDO role and recommend the Board offer Tanya Kaur the Sports Development Officer role for 24 hours per week. And the Social Media role for 10 hours per week.

• The Board envisions that both the Coaching Manager and SDO will give assistance to the Covid Recovery Specialist with the Covid Recovery Project.

## ANZ Updates:

- ANZ are looking at proposals to change the current fee structure. At present there are several options put forward. Some clubs have been invited to be part of a focus group looking at the different scenarios.
- ANZ have advised that Game Day are phasing out the product OST/One Sport (current database) and replacing it with a brand new and improved system named Game Day. They will be holding a Centre first 1-hour webinar with Game Day next Thursday evening 21/7/22.
