#### AGM:

- Date for AAI AGM confirmed by Board as Thursday 25<sup>th</sup> July 2024. RR will follow Timelines on information out to clubs.
- DS agreed to compile the Annal Report once again and BH reminded Board and Section Convenors that draft reports need to be sent to DS by the end of May.

#### AAI Team Wear:

- JR asked if the Board would consider selling AAI Team Wear to Auckland Selected Athletes attending NZ Championship events to augment team spirit.
- This idea would only work if a direct ordering relationship was set up with a supplier with no cash outlay which the Board is in agreement with. JR to make inquiries with some Suppliers and ascertain how the Office would need to administer from an accounting prospective.

#### **Strategic Plan and Business Plan Review:**

 Strategic Plan Development Process Timeframe step 4 (Hold Strategic Planning Session with Board Members) to go ahead Sunday 21<sup>st</sup> April from Noon to 3pm. Venue has been changed from Mt Smart to Dianne and Paul Craddocks home. Draft plan will then be written up during May.

### ANZ Update:

- ANZ Centre Leaders Meeting Thursday 4/4/24. MM reported on Meeting where ANZ HP Director Scott Newman (SN) overviewed ANZs HPSNZ funded Track and Field High Performance Programme which (due to the funding parameters) is focused on winning medals at the Olympics. It was acknowledged that athletics (like many other sports) is challenged financially to appropriately fund other aspects of talent development and non-Track and Field High Performance which is largely a user pays model at this point in time.
- ANZ have recently appointed Technology and Membership Manager Libby who started her role on 3 April. ANZ CEO Cam Mitchell provided an update on ANZ Technology Review once finalised ANZ will share this with the centres and Libby will lead the implementation of the recommendations from this review. LM will engage directly with centres re Game Day. Tina was acknowledged for her work in supporting the centres and club with Game Day last season.
- NZ T&F Championships AAI Board commented on some medal issues around available medals for U16 age group events. These have since been ordered.

• 2024/25 Season dates discussed which may result in clashes with Track and Field calendar and the World Indoor championships scheduled for 21-23 March and the need to deliver five World Athletics events and Nationals in addition to other key events. AAI Board commented that if the NZ T&F championships were to be bought forward this may affect flights/accom already put in place. DC commented that it is more cost effective to have championships for 2 years in the same region.
