## **AAI 2025 AGM:**

• Draft Annual Report has nearly been finalised. Awaiting audited financials.

# Youth Advisory: Establishing a Youth Advisory Council for the AAI Board

- Purpose: The Auckland Athletics Board is committed to fostering inclusivity and strengthening youth engagement across the sport as part of the 2024 2029 Strategic plan and is a key contributor to delivering on the ambition to be an organisation with over 10,000 members by 2029.
- To achieve this, the Board is proposing the establishment of a Youth Advisory Council (YAC) to ensure the voices, ideas, and perspectives of young people are actively heard and influence strategic decision-making.
- PC asked if the name could be changed to Youth Athletes Council

• CD asked if another Board member needed to be added to the Sub-committee with JRat leaving. Decided that 2 would suffice.

## **Summary of Sub-Committee:**

- Objectives of the Youth Advisory Council
- Provide youth perspectives on key policies, programmes, and initiatives.
- Support the development of youth-focused opportunities within athletics.
- Encourage greater youth participation and retention in the sport.
- Act as ambassadors for athletics within their clubs, schools and communities.
- Structure and Membership
- **Composition**: 8–12 members aged 14–20 from across the Auckland region, reflecting representation across gender, ethnicity and athletic experiences.
- **Term**: One-year term, with the option to reapply for a second year.
- **Selection**: This will involve a combination proactively contacting individuals and an open application process reviewed by the AAI Board members who are the facilitators of the programme.
- Facilitator(s): Up to three AAI Board members who will participate as facilitators and mentors to the YAC.
- Recruitment and Selection Process
- Public call for applications through athletics clubs, schools, and AAI social media.
- Applicants submit information detailing their experience and interest in joining the YAC.
- Interviews may be held to ensure balanced representation.
- Selection will aim for balanced representation, enthusiasm, and leadership potential.
- Meetings and Operations
- A Chair will be elected by YAC members during the first meeting.
- YAC will meet quarterly, ideally in person or virtually if necessity requires this for all members to attend.
- Meetings will be guided by an agenda, and minutes will be documented.
- Members may be invited to present at Auckland Athletics Board meetings as needed.
- A budget will be allocated to support group activities and participation (e.g., travel, catering).
- Support and Development
- YAC Members will participate in an initial induction covering governance, leadership, and the structure of Auckland Athletics.
- Members will receive leadership training and mentoring.
- Regular feedback will be sought to ensure the group remains impactful and relevant. As part of being a Council member of YAC, offer 'service' status for their schools i.e. students will undergo umpiring, coaching or captaincy roles within a sport for 'service' points or status towards a larger award within the school environment. Being on the YAC is a service to their sport, and we can work with members with their respective schools to ensure they are recognised for their efforts, i.e. provide an end of year service report to the schools.
- Opportunity to offer a pin to be given to the council members that could be worn on their blazers/school uniform. At the NZSS nationals, the pins given out for making a team are highly sought after.

## Reporting and Accountability

- The YAC will report to the Auckland Athletics Board through quarterly summaries.
- Feedback and outcomes from YAC discussions will be included in Board planning and decision-making processes.

## **Timeline for Implementation**

• **September**: Finalize terms of reference and promotional materials.

**October**: A dual pronged approach with open applications and promotion through key channels and directly approaching identified prospects.

• November: Select and induct members.

• **December**: Hold inaugural meeting and orientation.

# **Long-Term Vision and Impact**

The Youth Advisory Council is designed not only as a consultative body, but as a leadership incubator and catalyst for deeper youth involvement in athletics governance. Its establishment will:

- Strengthen the long-term relevance and responsiveness of Auckland Athletics.
- Inspire a new generation of volunteers, coaches, and decision-makers.
- Ensure that policies and programming better reflect the needs and expectations of young athletes.
- By embedding youth perspectives into governance processes, the Auckland Athletics Board takes a proactive and strategic step toward a more dynamic, inclusive, and resilient future for athletics in the region. The group will serve as a vital conduit for fresh ideas, youth engagement, and long-term growth of the sport in Auckland.

## **Aktive Initiative – Love Their Game:**

- Initiative to promote good sideline behaviour in all sports.
- Aktive are asking for buy in by signing a MOU. They will then provide a range of assets that can be used to promote and encourage appropriate sideline behaviour.
- CD asked if this could be turned into physical signage as well as digital. To be checked.

BH moved that MOU be signed and returned. Seconded CD, Carried.

## **Junior Event Co-Ordinator Role:**

- To co-ordinate the required inputs into Junior events including Pentathlon/Relay/Junior Championships and the GO! Series.
- After Board discussion the Board advised that this role would be more in keeping with a Honorarium rather than an hourly rate payment. It would therefore be supportive of an honorarium payment.
